

Terms of Use for Buyers and Sellers of Vehicles

By accessing or using the Service, Users imparts explicit consent that they have read, understood, and agree to be bound by these Terms of Use. These Terms of Use ("**Agreement**") govern the use of the platform or service of sale and purchase of Vehicles ("**Service**") provided by Wheelseye Technology India Private Limited, hereinafter referred to as "**Provider**," for buyers and sellers ("**Users**") of trucks, 4xl , __, ____, _____... etc ("**Vehicles**"). By accessing or using the Service, Users agree to abide by these terms and conditions.

1. User Accounts:

1.1. Users may be required to create an account to access certain features of the Service. Users agree to provide accurate, current, and complete information during the registration process and to update such information as necessary to ensure its accuracy.

1.2. Users are responsible for maintaining the confidentiality of their account credentials and for all activities that occur under their account. Users agree to notify the Provider immediately of any unauthorized use of their account or any other breach of security.

2. Listing Vehicles:

2.1. Sellers may list vehicles for sale on the Service, providing accurate and detailed information about the vehicles, including but not limited to make, model, year, condition, mileage, and price.

2.2. Sellers are solely responsible for the accuracy of the information provided in their listings and for ensuring that they have the legal right to sell the vehicles listed.

3. Truck Inspections:

3.1. Buyers are encouraged to inspect vehicles in person before making a purchase. The Provider does not guarantee the accuracy or condition of vehicles listed on the Service and is not responsible for any misrepresentations made by sellers.

4. Transactions:

4.1. All transactions conducted through the Service are solely between the buyer and the seller. The Provider is not a party to any transaction and does not act as an agent for either party.

4.2. Buyers and sellers are responsible for negotiating the terms of any transaction, including but not limited to price, payment, and delivery.

5. Payment:

5.1. Sellers may be required to pay a fee to list vehicles for sale on the Service. Fees, if applicable, will be clearly stated on the Service and are subject to change at the discretion of the Provider.

6. Prohibited Activities:

6.1. Users agree not to use the Service for any unlawful purpose or in violation of any applicable laws or regulations.

6.2. Users agree not to engage in any fraudulent, deceptive, or misleading conduct in connection with the Service.
